ADAPTIVE PHYSCIAL EDUCATION TEACHER

DESCRIPTION

The Adaptive Physical Education (APE) teacher is responsible for the development of an adaptive physical education program for Special Education students who require specialized instruction in physical, coordinative, manipulative skills. The teacher in this position must utilize a range of instructional techniques and strategies to enhance student progress, establish a productive learning environment, and provide individualized and small group instruction consistent with the Individualized Education Program (IEP) of each pupil.

MAJOR DUTIES AND RESPONSIBILITIES

- Utilize appropriate district and state curriculum framework guidelines, standards, policies and procedures
- Assess physical and perceptual motor needs of students in order to develop goals and objectives, and implement instructional plans for appropriate motor programs and activities
- Provide innovative, creative, and adapted physical education instruction for special education students
- Participate with the IEP team in the planning of an individualized education program for each student
- Develop appropriate instructional goals and objectives for each pupil based upon assessment and observational data
- Work closely with school personnel to complement and supplement academic concepts and consult with classroom teachers regarding physical education
- Analyze, demonstrate, and explain basic skills, techniques, and strategies of formal sports, games, rhythms, and fundamentals of body movement to students
- Provide adequate supervision of assigned students
- Regularly communicate specific, evaluative feedback to students, parents and general education teachers regarding student progress in meeting set goals and objectives
- Maintain professional competence through participation in in-service educational activities provided by the
 District and in other professional growth activities as needed to stay current in pedagogy and methodologies
 in Adaptive Physical Education
- Attend and participate in District Special Education meetings and site faculty meetings as needed
- Maintain required attendance data and other related records
- Provide leadership for the class Instructional Assistant(s) and direct his/her activities consistent with the instructional objectives of the adaptive physical education program
- Ability to work successfully with students, teachers, administrators, and parents and to communicate effectively, both orally and in writing
- Develop an effective instructional schedule to meet the required APE Instructional minutes of each student's IEP and travel to different school sites to deliver the APE program to students

QUALIFICATIONS

Knowledge of:

- Professional and technical knowledge of disabilities, learning styles, behavioral intervention strategies
- Effective methods of instructing students with special needs
- Growth and development of early childhood, grades TK-6
- Strategies for working with diverse intellectual and cultural backgrounds
- Basic knowledge of California State Standards in Physical Education
- Technological knowledge and skill to affect positive student learning outcomes
- Assessment administration, record keeping, and data analysis

Ability to:

- Teach small and large group classes
- Assess fitness levels of individuals with disabilities and to prescribe an exercise program designed to achieve individual fitness goals
- Use appropriate technology to enhance student learning
- Teach and communicate effectively

SUPERVISION EXCERCISED AND RECEIVED

This position is under the immediate direction of the Director of Special Education.

EXPERIENCE, EDUCATION AND CERTIFICATION

Any combination of experience and training that would likely provide the required knowledge and skill is qualifying. A typical way to obtain the required knowledge and skill would be:

Experience:

Successful teaching experience of Adaptive Physical Education students with disabilities.

AND

Education

Possession of an earned Baccalaureate of higher degree from an accredited college or university in physical education or related field.

Certification Requirement

Possession of a valid California Single Subject: Physical Education and/or a valid California credential authorizing instruction in Adaptive Physical Education credential, must also authorize autism and EL authorization.

ESSENTIAL JOB FUNCTIONS

- Visual ability to read handwritten or typed documents, and the display screen of various office equipment and machines
- Able to conduct verbal conversation
- Able to hear normal range verbal conversation (approximately 60 decibels)
- Able to sit, stand, stoop, kneel, bend and walk
- Able to sit for sustained periods of time
- Able to kneel or squat for extended periods of time
- Able to climb slopes, stairs, steps, ramps and ladders
- Able to lift up to 50 pounds
- Able to carry up to 50 pounds
- Able to push and pull objects weighing up to 100 pounds
- Able to sustain strenuous manual labor for a minimum of 3.75 hours
- Able to exhibit full range of motion for:
 - shoulder external rotation and internal rotation
 - shoulder abduction and adduction
 - shoulder extension and flexion
 - elbow flexion and extension
 - back lateral flexion
 - hip flexion and extension
 - knee flexion
- Able to demonstrate manual dexterity necessary to operate a computer and other classroom equipment in a safe and efficient manner
- Able to work with cleaning solutions, disinfectants and sanitizers in a safe and effective manner without allergic reaction
- Able to demonstrate manual dexterity necessary to assist students with buttoning clothing and eating, operate a computer, or assist staff with toileting/diapering procedures
