Leona Cox School will provide parents of participating children if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible: Parent suggestions and input via the School Site Council, English Learner Advisory Council, PTA, GATE Advisory, Parent Education Nights, Parent Information/Input and Title I meeting and informal talks with staff and administrators.
