# Correspondence and Board Information

Mrs. MacDonald shared that she could tell a lot of planning went into the 150th Celebration, and everything blended nicely. She said it was a fantastic event, and she could see the joy on people's faces, and that the school looked terrific. She stated that the building and ground used to look disconnected, however, now it is perfect and the school has an incredible field for students to play on. She said leff Combe was acting as Thomas Mitchell, and it was neat to see him in character. She thanked and congratulated the District on a fantastic event and celebration of 150 years of educating students.

Mrs. Weinstein shared she was disappointed that in all her years, she had to miss two significant events, the CLASS New Heroes Event and the District's 150th Celebration, but she was fortunate to be spending time with her new grandchild. She was able to view the 150th Celebration Live as the media was streaming it. She congratulated the whole CLASS Education Foundation and Dr. Fullwood, as she knows she was the driving force behind that event. She said the 150th Celebration was difficult for her to miss, but she could view some of it Live on Facebook while it was streamed and heard wonderful things. She heard it was a fantastic event with a great turnout, and everyone was thrilled. Teachers and students returned for the event, which looked like one big family reunion. She gave kudos to everyone involved and wished she did not have to miss it. She also said she attended the CSBA Webinar Emergency Response in CA Schools, and they had good information.

Mrs. Jellings shared that she went to the 150th Celebration with her family, and they had a great time. She said she didn't know the choir would perform, and their performance was outstanding. She added the CLASS Education Foundation event was fantastic.

Mr. Chase said he thought the CLASS Education Foundation New Heroes event was great. He said he had such a great time at the 150th Celebration, and that Mr. DeFigueiredo did a great job with his speech. He added that the history timeline display in the hallway is fantastic, and he would like that preserved. He was amazed by how many great conversations he had at the event. It was such a great turnout that he talked to so many people. He said he ran into an old neighbor, someone from the diabetes community, and met Phyllis Owens at the event, who had a fantastic display of items she put together from her time with the District. Ms. Owens worked with the District and had her children in the District during the late 70s, and he said he sat with her looking at the items she had on display, and had a wonderful conversation. He said he thought that the event was so great he had to wear his 150th shirt to commemorate it. He added that the Pinetree campus had undergone a lot of construction since their last Board Meeting there, and the campus was lit up beautifully, and both buildings looked fantastic. He said he was very impressed with the lighting, and what a great job was done. He said it was a long process, and he knows the community waited a long time for it.

Mr. DeFigueiredo echoed his colleague's comments about both of the events. He said everything was so well done and well received by the community, adding that there was excellent community involvement. He gave kudos to the CLASS Education Foundation and Dr. Fullwood for putting together a great event. He said he appreciates that the College of the Canyons let the District use their facility. He said Saturday's 150th Celebration was an absolute highlight. He jokingly stated the biggest sacrifice was the five years Dr. Kawaguchi lost her life putting the event together. He said it was great, and does not think the District should have to wait another 25 years to do something like that. He would like to do an event similar, possibly every seven years so that, at some point, all

students and families would experience that. He added maybe it would be great if school sites celebrated milestones at their sites.

Dr. Kawaguchi thanked everyone for their hard work in preparing for the 150<sup>th</sup> celebration, and said it took everyone to put the event together.

Mr. Chase added the food was fabulous at the CLASS Education Foundation event and wanted to thank everyone who donated. He said he thought that the paver fundraiser at the 150th was great and asked if that was continuing.

Mrs. MacDonald would like to thank the College of the Canyons, who offered to let the District use their facility for the New Heroes Event. She said it is an excellent way for the community to get to know local colleges.

Mr. DeFigueiredo thanked the California Living History for doing a great job with the Pioneer activities at the 150th Celebration.
